THIS INDENTURE Made this tenth day of January in year of Lord One Thousand Seven Hundred & Eighty Seven Between Aaron Vinson of Johnston County and State of North Carolina of the one part and Drury Vinson of the County and State aforesd. of the other part Witnesseth That the said Aaron Vinson as well for and in consideration of the natural Love and Affection which he hath and beareth unto the said Drury Vinson his Brother as also for the better Maintenance and preferment of the said Drury Vinson hath given granted aliened Enfeoffed and Confirmed and by these presents doth give Grant alien Enfeoff and Confirm unto the said Drury Vinson all my right and title to that messuage or tenement of Land my father John Vinson deceased <sup>formerly lived on and all the land adjoining the said messuage or tenement that the said</sup> died possest with at his death with all and Singular its appurtenances and all houses Out Houses, Lands &c and the reversion and reversions remainder & Remainders rents & Services of the said premises and all The Estate right title Interest property Claim and demand whatsoever of him the said Aaron Vinson <sup>the said messuage, tenement, lands and appurtenances and to</sup> in and to, every part and parcell thereof with the appurtenances and all Deeds Evidences and writings Concerning the said premises

TO HAVE and to hold the said Messuage & Tenement Land & premises hereby given and granted or mentioned or intended to be given and granted unto the said Drury Vinson his & assigns to the only proper use and behoof of him the said Drury Vinson his heirs & assigns forever. And the said Aaron Vinson for himself his heirs Executors & Administrators doth Covenant and grant to and with the said Drury Vinson his heirs and assigns by these presents that he the said Drury Vinson his heirs and assigns shall and lawfully may from henceforth forever hereafter peaceable and quietly have hold Occupy Possess and enjoy the said messuage Tenement Lands Hereditaments and premises hereby given and granted or mentioned or intended so to be their Appurtenances free Clear discharged of and from all former and other Gifts Grants Bargains and Sales - feofments Jointures Dowers Estates Entails Rents - Rent Charges arrearages of Rents and of and from all other titles troubles Charges and incumbrances whatsoever had made Committed done or Suffered to be had made Committed done or Suffered by him the said Aaron Vinson his heirs Executors and Administrators or any other person or persons lawfully claiming or to Claim by former under him them or any or either of them,
