Ads^s or assigns forever And do by these presents do Give grant, Bargain Sell and Confirm unto John Vinson his heirs and assigns forever, one half a track or parcel of Land the sd. John Youngblood lives on he purchased of George Cole, the North side of Nuse River near Green's path in the aforesaid County and Province Beginning at 2 bush trees at the mouth of Small branch runing up the said branch to the said back line bairing No. 30 W. 200 po. runing to end of the same then So. 60 Wt. to the River then the Courses of the River to the Beginning Containing to 75 Acres more or less. Together with all the rite profit benefit privilege of Wood Water Timber timber trees Houses fences Orchards Necssarys with all other Necessarys Appertaining or belonging to the to the aforesaid premises, the one half of Gold and Silver Mines Excepted,
