The deed books of Johnston County beginning in the year 1746 (year of formation) to 1759 were destroyed in a fire. (There is a compiled index of these burned books which lists grantor. grantee and date of deed.) As several of these 'burned deeds' appear to be mentioned in the following abstracts, a separate listing is given on page c of deeds dated prior to 1759 (the earliest being assigned deed #210, dated 17 June 1736.) As the full land descriptions have been included in the abstracts, perhaps some of the 'burned deeds' may be completed.

Deed Book A-1 appears to begin when court sessions began at HINTON'S Quarter (see: JOHNSTON COUNTY NORTH CAROLINA COUNTY COURT MINUTES, 1759-1766, Book I (Haun) 1974)

Deed Book B-1, besides being BADLY faded with some mutilated pages, contains the following notation: "Book starts with Page 187 All Before that can not be located" -"Many torn pages follow".

Deed Book Transcript-1 (assigned deed #406) begins a transcript of another deed book but unfortunately the original deed book number is not stated. As many of the GRAN-VILLE & MCCULLOCH Grants listed in Transcript-1 were abbreviated by the clerk, a verbatim transcript of one GRANVILLE Grant and one MCCULLOCH grant is presented on pp. i-v.

Deed Books D & D-1 contain the same land transactions. Both books appear to be transcripts but Book D appears to pre-dated Book D-1. The abstracts following were copied from Deed Book D-1 but were also edited by Deed Book D which some times contained additional information. Any additional information in Deed Book D has been included in the abstracts.

The latter part of Deed Book D contains Wills. As JOHNSTON COUNTY NORTH CAROLINA WILLS were abstracted and published in 1975 by Mrs. Elizabeth E. Ross, R.R.D. #1, Box 403, Clayton, N.C. 27520, these wills have not been duplicated.

Except for Deed Book B-1 (whose index is terribly mutilated) the original indices of the above deed books are presented on pp. vi-xi.
