The deed books of Johnston County beginning in the year 1746 (year of formation) to 1759 were destroyed in a fire. There is a compiled index ONLY of these burned books which lists grantor, grantee and date of deed but contains no other information. As several of these 'burned deeds' appear to be mentioned in the following abstracts, a separate listing of these early deeds is given on page iii. As the full land descriptions have been included in the abstracts, perhaps some of the 'burned deeds' can be completed.

The symbol + appearing after a name seems to indicate 'jurat': when appearing within a name it seems to indicate the person's signature.

Wills were usually referred to but a few originals do appear.

Names in the original indexes have not been duplicated in the compiled index.

A few names have been combined in the compiled index, such as JOHNSON & JOHNSTON.
